**FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER**

A hearing on the above-referenced matter was held before the Arkansas Motor Vehicle Commission ("Commission") on March 18, 2015 at the Office of the Commission, 101 East Capitol Avenue, Suite 204, Little Rock, Arkansas, 72201. No one appeared on behalf of Roll Out ("Respondent"). Finding proper notice had been given Respondent, the Board, from all the evidence presented, makes the following Findings of Fact, Conclusions of Law and Order:

**FINDINGS OF FACT**

1. Roll Out, located at 7706 Cantrell Road, Little Rock, Arkansas is a new motor vehicle dealer formerly licensed to sell Peace Powersports, Bashan MC's, and Goldenvale Roketa products.
2. Roll Out dealer license expired on December 31, 2014.
3. As of February 12, 2015, Roll Out, has not renewed its dealer license.

**CONCLUSIONS OF LAW**

1. Respondent's conduct, as set forth in the Findings of Fact 2 and 4 above, constitute a violation of Ark. Code Ann. § 23-112-101, *et seq.*, and the rules and regulations promulgated by the Commission pursuant to Ark. Code Ann. § 23-112-204, a violation of Ark. Code Ann. § 23-112-301, and violations of Ark. Code Ann. §§ 23-112-303, 23-112-308(a)(4), (a)(5), and (a)(19).

**ORDER**

1. Respondent's dealer license is hereby revoked pursuant to Ark. Code Ann. § 23-112-204, Ark. Code Ann. § 23-112-301, and Ark. Code Ann. §§ 23-112-303, 23-112-308(a)(4), (a)(5), and (a)(19).
2. Pursuant to the Arkansas Administrative Procedure Act, Ark. Code Ann. § 25-15-212, Respondent may petition for judicial review of this decision by filing a petition in the Circuit Court in the county in which he resides or does business or in the Circuit Court of Pulaski County within thirty (30) days after service of this order.
