

**MINUTES OF THE ARKANSAS MOTOR VEHICLE COMMISSION**

**Business Meeting

**November 19, 2014**

The regularly scheduled meeting of the Arkansas Motor Vehicle Commission was called to order at 9:30 a.m. by Chairman, Sandy Stroope. Staff present included Executive Director Greg Kirkpatrick, License Supervisor Vicki Wright, Investigator Gordon McCoy, and Administrative Specialist Crystal Campbell. All Commissioners were present during the meeting. Also in attendance were Mark Ohrenberger with the Attorney General's Office; Court Reporter Susan Whitson; Hearing Officer Peggy Johnson; Complainant Laura Fowler and husband Kenny Fowler; Representing Crain Hyundai Attorney Jamie Jones with Friday Eldredge Clark, Chris Byrd, Platform Director and CFO with Crain Automotive, and General Manager Stephen Hawkins; and Complainant Rocky Fulkerson and Brandon DeGroat, CFO with Crain Ford Colonel Glenn.

The minutes from the September 19, 2014, meeting were reviewed and approved unanimously as written following a proper motion and second.

The Commission unanimously approved the expenditures for the November 19, 2014, meeting following a proper motion and second.

The fiscal reports for September 2014 and October 2014 were reviewed and approved unanimously following a proper motion and second.


The Commission approved the ad hoc committee recommendations as presented.

The Commission then moved to H#14-012, Laura A. Fowler vs. Crain Hyundai of Bentonville. Following testimony by the above consumer and representatives from Crain Hyundai of Bentonville, and questions from the Commissioners, the Commission unanimously approved a motion that Crain Hyundai violated Ark. Code Ann. § 23-112-706 for failing to provide notice of damage in excess of six (6%) of the sticker price of Mrs. Fowler's vehicle, and approved a motion to fine Crain Hyundai two thousand five hundred dollars (\$2,500.00).

The Commission then moved to H#14-013, Rocky Fulkerson vs. Crain Ford Colonel Glenn. Following testimony by Rocky Fulkerson and Brandon DeGroat, and questions from the Commissioners, the Commission unanimously approved a motion that Crain Ford Colonel Glenn violated Ark. Code Ann. § 23-112-316 when they sold Mr. Fulkerson's trade-in prior to the completion of the contract for sale, and approved a motion to fine Crain Ford Colonel Glenn one thousand dollars (\$1,000.00).

Chairman Stroope accepted a proper motion and second to adjourn the meeting.
